Cabin Policies

NO SMOKING ALLOWED IN ANY NORTH COUNTRY RIVERS FACILITY, INCLUDING CABINS! If there is any evidence of smoking, or the cabins smell of smoke and requires extra cleaning, a charge of \$200 will be put on the credit card of the original reservation.

All guests are required to check in at the front desk upon arrival.

Picnic tables and fire rings are not to be moved for any reason.

No fires will be permitted outside of the established fire rings.

Do **NOT** cut trees...alive or dead.

Please help us recycle. Bins have been made available, please use them.

Please be courteous and show respect to other guests. Guest who are disruptive and/or disrespectful to other guest or North Country Rivers staff will be asked to leave and no refunds or credits will be issued.

Please remember the Kennebec River is public property. Swimming, boating, tubing or any other water related activity is completely at your own risk.

Please wash and put away all dishes used in the cabins.

Please shut off all heat or air conditioning in the cabins and leave the door unlocked when checking out.

Uses of fire extinguishers for anything other then fire related emergencies will result in charges to Trip Leader reservation for replacement.



A minimum fee of \$150 will be charged to the credit card under the name the original reservation if any additional excess cleaning or replacement of any items in the cabins is needed.

We are located on an active airfield. ATVs are not allowed on the airfield for any reason. Only permitted

personal vehicles may drive on designated roads onto the riverside campsites and platform tents on the airfield.

You are welcome to use the airfield for non-vehicle use (soccer, frisbee, wiffle ball etc), just keep an eye out for landing aircraft. Personal Aircraft are welcome to use our airfield at anytime and do not require permission ahead of time.

Pet Policy

North Country Rivers prides itself on being a Pet Friendly facility, however all dogs must be registered with the Main Office. All dogs must be attended to at all times, and must be kenneled if left alone in a cabin.

There is an additional charge of \$20 per dog per night for the cabins and an additional minimum of \$150 will be changed for any extra cleaning original of the reservation.

Dogs may not be left in cabins after check out for guest only staying the night before your trip. If that is the case, you will need to find accommodations for your dog while you are gone. They may not be left unattended at any time in the campground.

It is in violations of Maine State Law to leave your dog unattended in a car. North Country Rivers believes is the fair and humane treatment of all animals.

Please be courteous of others and pickup after your dog.

We have two company dogs, two yellow labs: Maggie and Murphy. They are very friendly and are allowed to roam freely around the property. If you have a campfire, or eat outside it is VERY likely they will come pay you a visit. PLEASE DO NOT FEED THEM! They are on very strict diets, and human food can cause serious problems for them.



Check-Out Policy

It is very important to keep our cabins looking as beautiful as possible for everyone. For that reason we ask that you check out at 10am on the day of your departure so that our wonderful housekeeping staff can prepare the cabin for our next guest.

If you are checking out the day of your trip, you must remove your belongings from the cabin and your car from the driveway BEFORE you leave for your trip. If you are not checked-out before you leave, North Country Rivers will pack up and remove your personal belongings, and there will be an additional charge of \$48/person for one day of lodging. (This also means you may NOT enter the cabin after the trip.)

Our Housekeeping staff work very hard to keep all eight of our cabins clean for your arrive. Gratuity is welcomed and can be left in the provided envelopes.



Personal ATV Use

ATVs are not allowed on the airfield at anytime unless authorized by the Main Office. Any ATVs found driving on the airfield may be asked to leave by North Country Rivers personnel.

Please note there are several busy times in our parking lot, we would appreciate if you would drive either before or after these times to avoid extra traffic and dust. Between 8:00am – 9:30am and 3:00pm – 4:30pm

Each ATV must be registered with the Maine Department of Fisheries and Wildlife and with North Country Rivers. This applies to all Maine residents as well as non-residents.



All ATVs must also be operated in accordance with the rules and laws established by the state of Maine and the Maine Dept of Inland Fisheries and Wildlife. A full list of all Rules and Regulations for ATVs can be found at http://www.maine.gov/ifw/rv/atvlaws.htm.

To register your ATV you can go to The Bingham Town Office and they can issue State of Maine registrations. Registration fee is \$34-Residents, \$69 - for a Non-Resident. Bingham town office can be reached at (207-672-5519), and office hours are Monday - Friday (9:00 AM - 4:00 OPM).
